STATEMENT OF APPLICANT 39337. SWORN and admonished that if at any time he should fail to understand the interpreter to at once sostate also advised as to the natue of and the penalty for the crime of perjury. Speaks Sam Yup, Sun Dock dialect.

- Q What are all your names? A LEONG MOON, LEONG JOW GING, American name is WILLIA M LEONG.
- Q What is your age and place of birth? A I am 55 yrs. old, born Low Jow Village, Sun DockDist., China.
- Q When did you firstcome to the U.S.? A KS 23 (1897) , SS Rio de Janeiro, sec. 6 Mer., g under the name LEONG MOON.
- Q Have you any papers to show that Lending? A No, I did have a sec. 6 paper, but it was destroyed by fire in S.R. in 1906.
- Q What is your occupation and present address? A I am manager of the H. Williams & Co., 1108 Stockton St., San Francisco; I reside at 101 -8th St., Oakland, Calif.
- Q Why are you appearing here today? A I wish to obtain a laborer's return certificate; I wish to make a trip to China with my family.
- Q How many members of your family are going with you? A My wife and 7 children.
- Q Are all those 7 children actually going to China with you? A Yes.
- Q Have you appy immigration papers in your possession now whatsoever? A No, when I returned to the country after making a trip to China in 1909 I gd my attorney to make an affidavit for me stating that I was legally admitted, but thit was lost. At the same timeI had this made I had one made for my wife, which she still has, but my name does not appear on her affidavit.
- Q On that do you have your right to a return certificate? A On the grounds that I have \$1,000 on deposit at the Bank of America, Chinese branch, San Francisco. The passbook was issued to me; at the time I spoke to my attorney about securing a laborer's return certificate I lost this book. I immediately went to the bank about this and I was promised that another one wouldbe issued to me in about a week's time. I forgot to call for this book last Saturday, but I will obtain a new passbookas soon as possible.

Q Have you a bankbook for your wife? A Yes, she has it.

Q Where did you obtain this \$1,000 that you haveon deposit at the bank? A It was savings from my earnings.

Q Did you borrow any portion of it? A No.

Q Do you intend to leave that money on deposit at the bank until you return from China on that trip? A Yes.

Q What salary do you receive as manager of that store? A \$90 a month.

Q Where did your wife get the \$1,000 that she has on deposit at the bank? A She saved up that money.

Q Did you give her any of it? A Yes, all of it was saved from the money I gave her.

Q Can you read in any language. If you cannot you must return to the U.S. within 6 months from the time of your departure? A Yes, I can read Chinese.

Q How many times have you ever been married? A Once only.

When and where were you married? A I was married either in KS 20 or KS 21 (1894 or 1895) I cannot remember thementh or day, in the Low Jow Village, S.D.D., China.

Q Describe your wife? A LOW SHEE, age 52, I think, here today, an applicant.

Q How many children have you ever had? A Eight: 5 sons, 5 daughters. All of my children are living.

Q Describe them? A Sons are:

LEONG QUAN, 34 yrs.old, Ithink bornin KS 22-7-7 (Aug. 15, 1896), born in China, now in San Francisco.



SUMMARY

These applicants are applying for return certificates as laborers and natives respectively. The alleged husband and father LEONG MOON(39337) claims to have first come to the U.S. in KS 23 - 99 or 10 (Oct.or Nov.1897) SS Rio (de Janeiro) as a Sec. 6 Hong-kong merchant. According to the prior records his Sec. 6 certificate was burned in the earthquake and fire. There are no papers in his prior file 10373/1618 to show this landing. He has made 1 trip to China, departing June 24, 1909, and returning Dec. 17, 1909. He was accompanied to the U.S. on his return from that trip by his alleged wife LAU SHEE, (39338) and a foreign-born son LEONG QUAN. Neither of the parents have been to China since that time. They both are in possession of savings department passbooks showing \$1,000 on deposit and the Bank of America of California.

Applicants 39339 to 39345 incl., are from 7 yrs. to 20 yrs. old, respectively; they have all been attending school, WILLIE IEONG, 59345, is now attending the University of California; HARRY LEONG, 59359, is attending the Westlake Jr. High School, Oakland, while the rest of the are attending the Lincoln Grammar school in Oakland. They each produced their school records which is in agreement with their statements. The testimony of the alleged parents on the conditions surrounding the births of the native-born applicants is in good agreement. It is noted that a certified copy of birth certificate has been filed for each applicant and a certificate has been executed by the attending physician in eachcase. I believe that each of the native-born applicants
